You, the bride are responsible for coordinating the payment in full, minus the deposit, due on the day of the wedding. Gratuity is not included in your final total. Please feel free to contact me anytime with any questions or concerns you may have. I look forward to helping you, to make your day absolutely perfect!!!

\*A deposit of \$100 is due upon the completion of this contract. Deposits are nonrefundable

\*A Credit Card on file is required to reserve your date. You may include a check for the deposit if you would like. (Visa, Mastercard, or Discover)

\*Pricing: Updos/downdos: \$80 Blowouts/flower girls: \$50 Bride \$160 (Includes trial run)

\*30 day minimum notification is required to cancel any/all services

\*Kelly reserves the right to charge the credit card on file for the full amount of services booked if canceled within the 30 days.

\*No shows will be charged the FULL amount for scheduled appointments.

\*Travel total is based on mileage plus any other travel costs incurred pertaining to the wedding. Travel by boat will be priced on a case by case basis. (\$1.00/mile)

\*The only instance a deposit will be refunded is stylist is unable to carry out or perform duties.

\*Please be ready to start at the agreed time with CLEAN DRY HAIR. I highly recommend that you and party, wash and dry your hair without styling product. Stylists do NOT schedule time to blow dry hair on the wedding day, unless specifically booked. There will be a \$35 surcharge for those who do NOT blow dry their hair prior to seeing stylist.

\*If a check is returned, there will be a fee of \$25 settled no later than 30 days prior to the event
